**Your home address and telephone and a personal e-mail have been requested, because federal law prohibits engaging in political activity in government buildings, using government resources or on government time. You are allowed to establish financial allotments using government resources.*

PLEASE READ AND SIGN BELOW:

Contributions to NASCOE PAC are limited in total to \$5,000 per calendar year. NASCOE PAC uses the voluntary contributions it receives to make political contributions to candidates, parties and other political organizations. NASCOE members may refuse to contribute to NASCOE PAC without fear of any reprisal. Any suggested contribution amounts or levels are merely offered for guidance and convenience. NASCOE members are free to contribute more or less than these amounts. The amount a NASCOE member contributes or a refusal to contribute, will not benefit or disadvantage that person. Contributions to NASCOE PAC are not deductible for federal income tax purposes. Contributions to NASCOE PAC must be made with personal funds, and may not be reimbursed, expensed or otherwise paid by another person. Contributions from corporations (including PCs) are prohibited, as are contributions from foreign nationals, other than those made by persons who are lawfully admitted for permanent residence in the U.S. (i.e., "green card" holders). NASCOE members may discontinue their payments to NASCOE PAC or may adjust the amount of their allotment at any time by contacting the National Finance Center.
